ELIGIBILITY and CONDITIONS OF ENTRY

General:

1. ALL competitors must be 4th Kyu or above or equivalent per JFA Inc Sporting Code.
2. All competitors must be current financial members of the JFA (NSW) Inc. or any JFA Inc. member state, or IJF recognized National Federation. Evidence to be provided at the weigh-in.
3. JFA Inc. registration books MUST be present and filled out correctly. An AU\$10.00 fine will apply if competitors fail to present their registration books. Alternatively, competitors may be prevented from competing if the organizers cannot verify registration.
4. ALL overseas competitors will be required to present passports at the official weigh-in for proof of identity and age. Proof of current membership and grade must also be provided.
5. The tournament Director reserves the right to abandon or amalgamate any weight divisions where sufficient members are not present – coaches will be consulted.

Weigh-ins

6. Athletes competing in more than one age category on Saturday need only Weigh-in once ensuring their name is listed on all required age category weigh-in sheets. Athletes entering Senior Divisions on Sunday must Weigh-in on Sunday even if they competed on Saturday
7. The 2007 NSW International Open will be played under IJF rules
8. **BLUE AND WHITE JUDOGIS MUST BE SUPPLIED AND WORN BY ALL JUDO COMPETITORS**
9. Anticipated weight division should be noted on the entry form although changes can be made at weigh-in.
10. Tournament Entry Fees are not refundable (Exceptional circumstances may be considered by the Board of Management, JFA NSW Inc.)

Medal Presentations:

11. All medallists will be required to wear a judogi or appropriate tracksuit for all presentations.

Competition Draws and Seeding:

12. Competition Draws will take place immediately after the closure of the Weigh-in per the attached timetable. Seeding of the draws for the 2007 NSW International Open will be as follows.
 1. Australian National Seeding points
 2. 2006 NSW International Open Results
 3. Non – Australian players will be seeded at the discretion of the Competition Management.
