General Expectations of State Representatives

The appointment to a State Team is prestigious and high profile and this should be reflected by a high standard of performance both in preparation for the event and during the competition and in overall behaviour. Athletes are representing NSW with all the attendant expectations and responsibilities of the JFA (NSW) Board of Management and its members. The athlete acknowledges these expectations.

Agreement

In consideration of the JFA (NSW) accepting the athlete as a member of the JFA (NSW) team/squad for the event and/or period shown, the athlete agrees as follows:

1. a) To comply with the requirements, including the terms and conditions for participation in selection tournaments and squad training, of the team selection procedures as set forth by the JFA in the attached document titled "State Team Selection Procedures and Selection Competition Format 2007".
- b) To attend the specified number of State squad training sessions and for senior athletes, National Squad training sessions, as required under the attached document, and to exercise his/her best endeavours to render him/herself fit for competition as required.
- c) To disclose immediately to the team coach, manager or other person appointed by the JFA (NSW) any injury, illness or other condition that might prejudice his/her taking part in the intended competition or activity.
- d) To comply with all reasonable directions and instructions given by the team manager or other person appointed by the JFA (NSW) during the required period.
- e) To promptly meet all administrative requirements outlined in the attached document, and in particular regarding the payment of deposit(s) and any other moneys relating to participation as a team member.
- f) Where applicable, and unless otherwise agreed in advance by the team manager or other person appointed by the JFA (NSW), to travel to and return from the event with other team members at the time(s) and by the means decided by the JFA (NSW).

g) Where applicable, and unless otherwise agreed in advance by the team manager or other person appointed by the JFA (NSW), to reside with other team members at the official accommodation venue, as decided by the JFA (NSW) for the required period.

h) To remain under the control, management and direction of the team manager, or other person appointed by the JFA (NSW) in all respects from the agreed date until his/her official release from the team.

i) To conduct him/herself in a proper manner as a representative of the JFA (NSW) at all times while a member of the team.

j) To wear only clothing authorised by the JFA (NSW) when required by the team manager or other person appointed by the JFA (NSW)

k) To permit the JFA (NSW) to utilise any photograph or other image of the athlete as it sees fit and at its discretion for the promotion of the sport of Judo, or in the interests of the JFA (NSW).
